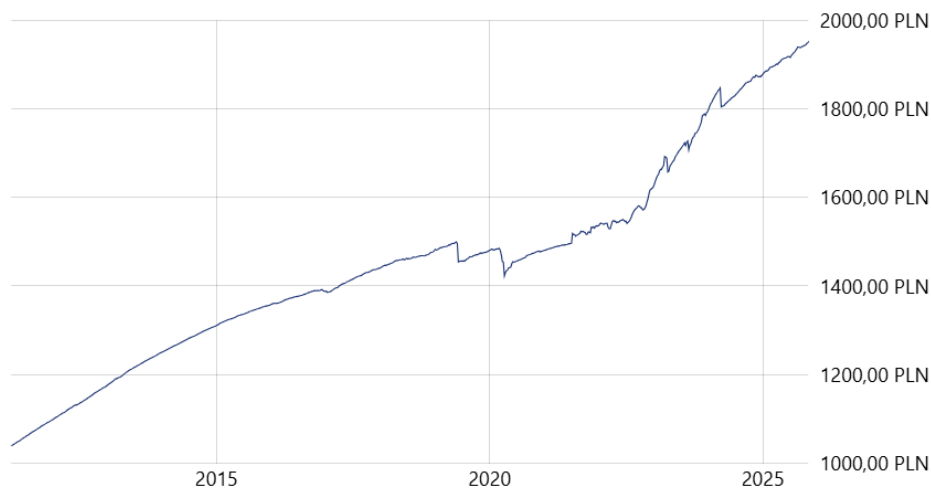

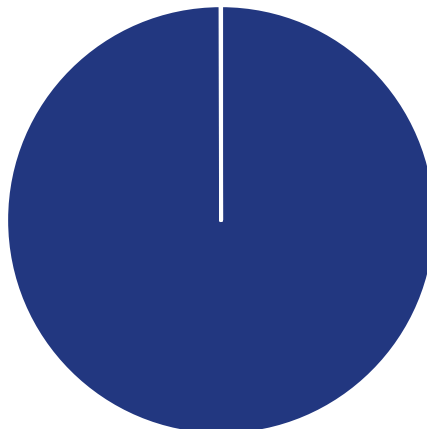
Currency exposure
