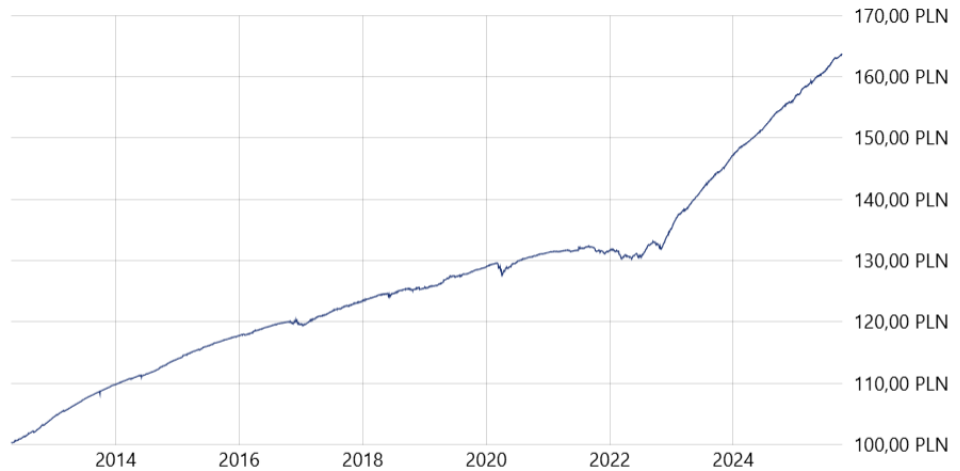

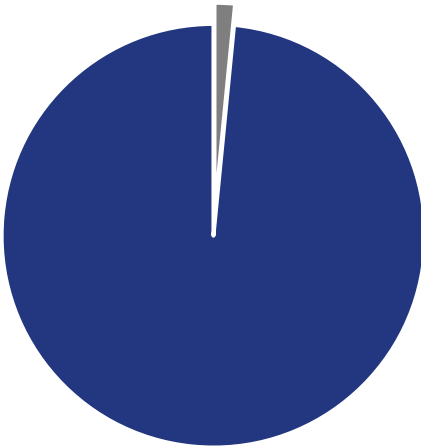
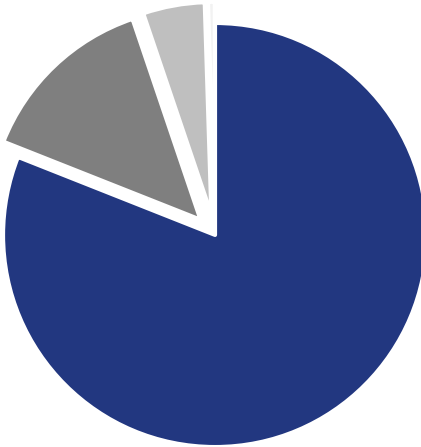

Geographical exposure

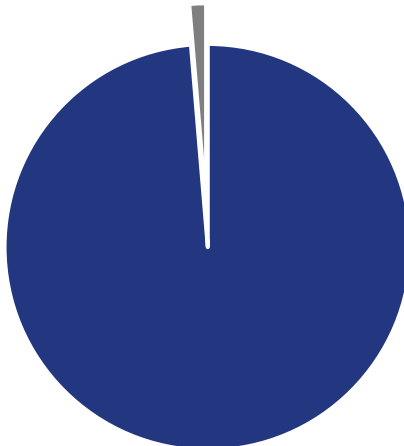
Poland – 98,7%
